Annual Fee Increase Questions & Answers

- Q. Why will the Board Of Directors (BOD) recommend a fee increase at this year's Shareholder's meeting?
- A. The BOD is looking to create a financial model that supports the upcoming Hickory Hill Dam capacity improvement project.
- Q. Why does Hickory Hills need to improve the capacity of the dam?
- A. After a Massachusetts dam failure occurred in 2008, the state changed the discharge capacity requirements for high hazard dams.
- Q. Why is Hickory Hills dam rated high hazard? Can we get that changed?
- A. The failure of our dam could result in loss of life and significant infrastructure destruction down stream. We investigated this with our engineer and after reviewing the inundation area the answer is no.
- Q. What is the discharge capacity requirement?
- A. The State requires dams must have the capacity to release 1/2 the Probable Maximum Flood (1/2 PMF) potential for the compound.
- Q. What is our current discharge capacity?
- A. Our spillway meets the discharge capacity of up to a 500 year storm.
- Q. I've heard that we only miss the I/2 PMF by a few inches. Does the state take that into account?
- A. Due to the near level nature of our dam/spillway and 1900' earthen embankment, once the water reaches the crest at the lowest point, it soon after breaches the entire embankment so the calculations essentially stop. What the model shows is a few inches of water across the entire embankment. Think of your bath tub over flowing. Once it reaches the rim, the additional water is irrelevant to the drain it spills on the floor.
- Q. Is the current Swale construction project part of the dam capacity project?
- A. The current project is being completed to address a safety concern that was raised by our engineering firm Tighe & Bond during our 2012 state mandated bi-annual safety inspection.
- Q. What is the Swale project?
- A. The project addresses "culling" or water that is seeping from the base of the embankment that is potentially pulling material from the core of the embankment. The top soil from the 400' collection area will be removed, a filter/retaining material will be installed and covered with rip rap.
- Q. Hasn't the collection area at the base of the embankment always been there? What changed?
- A. Although we have no "as built" plans of the embankment, we believe the collection area was intentionally installed to collect and direct the seepage to the Mulpus downstream (all dams have some normal seepage). Our engineer has observed sediment collecting that appears to be coming from the embankment.
- Q. What happens if we don't make the proposed upgrades?
- A. Currently our dam is rated as "satisfactory". We are making the improvements to maintain this rating. The satisfactory rating allows us to maintain a safe environment and keeps our insurance premium reasonable.
- Q. Why has the BOD come up with the tentative timeline of 7 years to make the capacity improvements to the dam? Is this set in stone? A. The BOD has been advised to prepare a long range plan that meets the capacity requirements in a timeframe we, in coordination with the Finance Committee, believe is fiscally responsible. Shareholders will be asked to vote on the final recommended plan in September. We will be reviewing the costs and finances annually.
- Q. Is the state mandating the performance upgrade?
- A. At this time the Office of Dam Safety (ODS) has not given Hickory Hills any specific deadline to complete the project. They noted in correspondences and on our construction permit the 1/2 PMF requirement and our intent to address the issue.
- Q. If the Office of Dam Safety (ODS) is not mandating the timeline why are we tentatively planning for 7 years.
- A. Hickory Hills has a long history working with ODS to maintain a safe and responsible plan to address concerns that have been brought to our attention via our bi-annual safety inspection, these include:
 - ♦ 1982 adding emergency spillway
 - ♦ 1996 replacement of the rip rap on the embankment
 - ♦ 2001- 2007 removal of trees from base of embankment
- Q. What happens if we don't do the upgrade?
- A. If and when the state mandates us to meet 1/2 PMF, we will be required to make the upgrades under their timeline. This timeline is an unknown that the BOD cannot plan for and could result in a marked and immediate fee increase to support. If the upgrades are not completed as mandated we would lose our satisfactory rating and ODS has the power to force us to reduce the lake level. Or even, though highly unlikely, breach the dam.
- Q. How do I as a resident, have a voice in this decision?
- A. Shareholders should attend the Annual Meeting on Sept 20, 2014, where everyone's voice is heard and vote is counted. If you're not a Shareholder, it's not too late to become one. Contact the Office for more information.





Beavers, beavers, beavers!

Recently, residents have commented that there is a greater than average beaver population on the lake. There is concern

about our natural vegetation.

Although many of us prefer the heron, fish, and bald eagle, our lake is also a natural habitat for the occasional Canadian goose, water snake and beavers.

Our Commonwealth mandates that beaver activity must be deemed a nuisance to public health or safety by local health department prior to issuing a permit for trapping and/or removal of our flat-tailed friends from their chosen location.

Trapping is usually only a temporary solution – those beavers are pretty smart and not prone to hanging out in traps. To protect lakefront flora and fauna, many suggest wrapping landscape cloth or wire around trees and large bushes.


Security Team & Contact Number

They are patrolling the lake area and beaches by boat during varied hours every day throughout the summer with Randy Gagne who we're happy to have back this year. Please be prepared to show your IDs and have boat stickers visible on all watercrafts, as well as your FREE resident car stickers on your automobile if parked at our lots. Your cooperation is appreciated.

Fanwort Update

As most of you are all aware, the invasive weed Fanwort, has unfortunately been found in our lake.

In order to try and prevent additional spreading, visual surveys are being done regularly by volunteers so we can identify any spread and remove it.



Areas of suspected Fanwort are being marked. If you see one of these markers (green noodle piece pictured here) in the lake, immediately leave the area.

Fanwort reproduces by fragmentation. Swimming or boating in an area

Noodle Marker with Fanwort could easily cause the plant to fragment & spread.



If you see fanwort floating on the top of the water, please pick it up. If you see it growing, immediately leave the area and DO NOT TOUCH THE PLANT.


