The Board of Directors held a few extra Board meetings this past March with the goal of ensuring all the information gathered was analyzed properly and our community was equipped with as many facts as could be gathered in the short time available.

While this may have taken some late hours, the Board would like to express their profound thanks to the many residents who expressed their deep appreciation for persevering with a positive message and offering the opportunity for individuals and businesses to make a difference supporting the conservation of our lake and protecting an important natural resource within our surrounding area. 
Take a Hike!

Hiking season is here! Time to enjoy some natural scenery with a hike through Hickory Woods! So set aside



2018 Annual Bills

The 2018 HHL annual license fee statements were mailed on April 1st and are due by May 1st. Included is this seasons Boat Launch Schedule (also found on our website).

Don't forget to update your email address and phone numbers. We only send I or 2 emails a month in the summer (rarely any off-summer), and we keep all contact information private.

We also ask you to make any changes on the provided boat form for boat purchases and edits to existing boats.

To obtain a **FREE** car sticker which enables you to park in the resident-only beach lots, **please include a copy of your current vehicle registration.** This is one of the few ways we have to insure only residents are using our lake facilities. Even if you had a car sticker before, we cannot issue stickers without first seeing a copy of your current vehicle registration.

Landlords please ensure the office has current names & phone numbers for your tenants and register any boats they have; provide them with IDs; and give a copy of the license you receive from the office. We appreciate your help & cooperation in keeping our records up to date.

Floating Logs

We'd like to thank everyone who removes floating logs found around the lake!

We are designating an area to store future logs on the

land between the Boat COVE and before the start of the Island Rd Beach (to the right of the COVE if you're looking at the beach from the water).

Please refrain from bringing floating logs near the temporary boat ramp (closest to Park St Ter) where the DASH & Security boats dock. It has become dangerous jumping off the boats with DASH equipment as well as a hazard parking the boats.



Looking To Help Our Lake? Come Join the DASH or Survey Teams!



The invasive weed Fanwort, continues to be found in our lake. Dedicated volunteers continue visual surveys regularly marking the plant with Orange H-shaped plastic markers for future removal by the Diver Assisted Suction Harvester (DASH) above. Our volunteer DASH teams will be focusing on shorelines and coves this season.



We hired AB Aquatics, Inc. to remove 4,865 gallons of Fanwort in 2 weeks last season! Their divers perform 6 hours of active suction harvesting per day and focused on newly discovered large patches from our deep water areas found by using Fish Finders. Pictured above are bags of Fanwort harvested from one day's work.



We are VERY excited to have AB Aquatics, Inc. come back this season to harvest Fanwort for up to 6 more weeks!



Remember, If We Don't Find It, We Can't Remove It

Fanwort Surveyors travel in any kind of boat or by snorkeling and mark plants with Orange H-shaped markers. Yellow markers indicate it's been removed and to please verify.

If a team has 4 members, the Captain's ask a team member to survey once a month so each zone is covered weekly. It just takes once a month for you to help save our lake:)

Interested in Fanwort Surveying? Here's how it works

We're a TEAM!

TEAM GOAL – Each team surveys their assigned zone at least once per week (preferably on a sunny, clear, calm day). Mornings or late afternoon seem to work best to view it. Wearing polarized glasses reduces glare, making plants easier to see.

TEAM CAPTAINS - Answer questions and create a team schedule.

If you haven't received your survey schedule, email your captain or fanwort@hickoryhillslake.com

MARKERS – H-shaped orange markers mark each group of plant(s) in the lake.

Release the weight into the water. String unraveling stops when weight hits the lake bottom. The DASH harvests plants & replaces Orange markers with Yellow. Your team then verifies Fanwort is removed.

Return Yellow markers to any Marker Bucket - DASH needs them to mark harvested locations!



MARKER PLACEMENT- 5' in front of plant: shore ---> plant ---> marker

MARKER SUPPLIES – Milk crates are located on docks or beaches around the lake and stocked with Orange Markers for Surveyor's to mark Fanwort plants. The location of crates is indicated by a RED STAR on the map.



REPORT FANWORT LOCATION – If you think you found Fanwort, drop a orange marker there and send an email to: fanwort@hickoryhillslake.com. Include the Zone # and Property # or Zone # and Island # it's closest to.

. Report Like This → Zone #, Property/Island #, short description (small/large, 10' off shore, etc), # of Plants, # of Markers

GOOGLE MAP GPS LOCATION - Sending GPS Location of Fanwort with your smart phone. This is Optional



- 1) OPEN the GOOGLE MAPS APP
- Press and hold the BLUE DOT that's marking your location. You'll notice a "DROPPED PIN" message now displays.
- 3) Select the words "Dropped Pin" that just appeared below the map
- 4 & 5) Select the word "SHARE", then select your email account.
- 6) The pre-populated email just created, includes a link to your GPS location, so just add the Zone #, Property # and how many plants it's marking to the email, and send it to fanwort@hickoryhillslake.com to report your sighting.

GPS location will be helpful to survey again there at a later time or early next season by divers & DASH teams

Additional Survey Tips:

- 1) It's helpful to have a marker ready to toss close to the plant as you spot it. This helps you find it again as you float away a little and then you're able to slowly paddle back and adjust the marker at the proper spot.
- 2) The H-shaped markers sometimes need one manual flip after it's reached the bottom in order to sit flat on top of the water.

FANWORT FACTS:

- July 22, 2011 two board members discovered hundreds of plants in our Boat Cove – survey's began & on September 11, 2011, about 5 plants in Queen's Cove were found next
- As of 2017, every part of our lake has seen Fanwort
- No known lake has ever eradicated Fanwort
- Our mission is to keep Fanwort at bay (maintenance mode)
- 5 Ways to reduce Fanwort are DASH, Hand Pulling, Benthic Barriers, Drawdown and Chemicals
- Fanwort is not the only invasive weed found in other lakes
- Boat trailers are the highest risk of invasive weed entry
- Fanwort spreads by fragmentation breaking it, i.e. motors, fishing lures, turbidity, auto-fragments on it's own in the Fall

FANWORT



PURPLE LOOSETRIFE

Purple Loosestrife is an invasive weed found at the shorelines here at Hickory Hills Lake. It can grow between 2 and 7 feet high. Purple loosestrife invades marshes and lakeshores, replacing wetland plants. The plant can form dense, impenetrable stands which are unsuitable as cover, food, or nesting sites for a wide range of native wetland animals. Once in aquatic systems, seeds are easily spread by moving water and wetland animals.

IDENTIFYING PURPLE LOOSESTRIFE



Flower: Individual flowers have five or six pink-purple petals surrounding small, yellow centers. Each flower spike is made up of many individual flowers.



Seed Capsule: As flowers begin to drop off, capsules containing many tiny seeds appear in their place. Depending on where you live, plants may go to seed as early as late July.

Seed: Each mature plant can produce up to 2.7 million seeds annually. As tiny as grains of sand, seeds are easily spread by water, wind, wildlife and humans. Germination can occur the following season, but seeds may lay dormant for several years before sprouting.



Leaves: Leaves are downy, with smooth edges. They are usually arranged opposite each other in pairs which alternate down the stalk at 90 degree angles, however, they may appear in groups of three.

Stalks: Stalks are square, five or sixsided, woody, as tall as 2 meters (over 6 feet) with several stalks on mature plants.



Rootstock: On mature plants, rootstocks are extensive and can send out up to 30 to 50 shoots, creating a dense web which chokes out other plant life.

REMOVING PURPLE LOOSESTRIFE

It easiest to remove plants with larger roots by easing the root out with a garden fork. Remove as much of the root system as possible, because broken roots may sprout new plants.

Once flower petals start to drop from the bottom of the spike, the plant begins to produce seed. Remove all of the flowering spikes by bending them over a plastic bag and cutting them off in the bag. Cutting of stems or pulling can now begin without fear of spreading the tiny seeds.



PURPLE LOOSESTRIFE ZONE MAP



Safety Reminders

Please help us keep our Islands safe from fire and follow our no fires on islands policy.

Got Weeds?

The Lake Management Group of Hickory Hills Lake is excited to be able to offer owners of lakefront property a simple means to allow them to use their waterfront free of the nuisance of lake-bottom weeds.

The Lake Management Group (LMG) has been installing **benthic barriers** to help control lake-bottom weeds, and this will be the third year that we are offering to purchase materials at cost for any lakefront landowner who would like to deploy them on their own waterfront (materials paid by landowner). We ask that any interested party donate some volunteer time for the activities of the LMG.



The benthic barriers are composed of biodegradable burlap sheeting and are held in place on the bottom with burlap sandbags, also biodegradable. The barrier prevents light from getting to the weeds, killing them in about 10 weeks. We suggest that the barriers be left in place to decompose, but they can be removed if you desire.

We have a limited amount of materials on hand and may have to place orders based on demand. Pricing is based on actual costs with no markup. The barriers are most effective when placed early in the season before weeds get too large.

Pricing (2018) - based on cost plus shipping and handling

Burlap sheeting and sandbags:

10' x 30' with 21 sandbags, one buoy: \$ 65

Waterfront 30' x 30', incl 3 strips, 50 sandbags: \$160

Actual costs may vary slightly due to inflation and actual shipping expenses. Sale is contingent on approval of application by Hickory Hills Board. We will provide instruction but installation is by homeowner.

If you are interested in more than a 30' x 30' benthic barrier or have installed one previously and want to expand your coverage, please put in your request and the Hickory Hills Board will consider your particular situation.

There is no poop fairy — Please clean up after your dog

While most dog owners have never heard of the mythical figure, they said they wished it was real.



Not only is dog feces un-

pleasant to look at and smell, it can also make people and other dogs sick. Dog waste contains harmful bacteria and parasites such as E. coli, giardia and salmonella that pets or people can pick up if they come in contact with it.

Bacteria from dog waste can also contaminate groundwater and bodies of water such as creeks, rivers and lakes.

Dog waste also does not biodegrade as quickly as other animal waste. Because of the type of food that dogs eat, dog waste can take up to a year to decompose. The more hard waste left behind, the more it accumulates.

Boating Basics Course



"Boat Massachusetts" is offered to the public at no charge. The primary purpose of the course is to foster safe boat operation through increased awareness of required safety equipment, safe boating practices and legal responsibilities.

Youth 12 to 15 who successfully complete the course, will be issued a Safety Certificate allowing them to operate a boat without adult supervision, as required by state law. All graduates will be issued a course completion diploma and a Safety Certificate. Taking the class as a family is encouraged and has proven to be highly rewarding.

Dam Overtopping Project Update - Dam Committee

Most of our Hickory Hills neighbors are aware of the "Dam Project" we have been working on for the past few years. I would like to give you an update on the overall progress of the project.

Background

Just to refresh everyone's memory, the Office of Dam Safety changed the requirements of large dams (which HHL dam is) after the near failure of the Mill River dam in Taunton in 2005. Before 2005, the requirement for large dams was to withstand a 500 year flood which in our watershed is the equivalent of 11.7 inches of rain in 24 hours. Our dam meets that requirement because all the water will flow through the main and auxiliary spillway, (i.e. the concrete portion of the dam) down the Mulpus Brook.

Sometime after the 2005 event, the requirement was changed to a ½ Probable Maximum Flood (1/2 PMF). For our watershed that equates to 15.5 inches of rain in 24 hours. For our Dam, the models suggest this amount of water will fill the concrete portion of the dam and overtop the earthen portion of the dam by 3 inches. If it were to do that, the state is concerned the earthen embankment could erode away and the dam could open sending billions of gallons of water downstream.

(I once thought this amount of rain was improbable in our lifetime but several years ago, parts of western MA received over 18 inches of rain in just 24 hours and just last year, parts of Texas received over 50 inches of rain in 48 hours, so unfortunately, these large storms are becoming more frequent.)

The Solution

The Dam Committee (J. Fortune, E. Manseau, J. Bingham, S. Douglas, P. Bertram, J. Beale and T. Bertram) along with the dam engineering experts, Tighe and Bond (T&B), have been working on a solution to meet the ½ PMF requirement. Since the main concern is erosion of the embankment, T&B have designed a solution using GeoWeb overtopping protection. To apply GeoWeb to our dam, the surface of the embankment will be scrapped down 4 inches. The webbing is rolled out and then stretched into place and anchored down over the main body of the embankment. It will be cemented into place where it meets a solid surface (road, telephone pole, gatepost etc.). Finally, the GeoWeb is backfilled with crushed stone on top and loam on the sides where new grass will be planted. The result will be an erosion proof, green lawn along the entire length of the earthen portion of the dam.

Progress So Far

To begin such a project, Hickory Hills Landowners Inc. (HHLI) must have the design approved by I) Office of Dam Safety, 2) Department of Environmental Protection (DEP), 3) Lunenburg Conservation Commission (LCC), and 4) Lunenburg Selectmen and 5) Town vote. To get approval, we created a 400+ page binder with forms, designs, Hydrology studies, wetlands studies etc. to submit to each of the groups above. I'm happy to say our hard work has paid off and we have approval from the first three groups.

The Selectmen are aware and in favor of HHLI meeting the state requirements, so we believe with the Office of Dam Safety, DEP and LCC approvals, they will also approve. The final hurtle will be town vote. Since our dam is adjacent to Townsend Harbor Road, in some areas the legal easement from the road

falls on the dam. Since the overtopping needs to connect to the road surface in order to be fully effective, work will need to be done with-in this easement. For any permanent changes to be made with-in the easement (in this case adding the overtopping protection), the town must approve it at Town Meeting. A positive vote will be required in order for us to proceed.

Please attend the May 5, 2018 Lunenburg town meeting and support this article.

What's Next?

With your support on May 5th, we believe the project will be approved by the town. Once it has, the Dam Committee will send out Requests for Proposal (RFP) to state qualified vendors to do the work. This RFP process will take us into the summer of 2018. Our goal is to have a vendor selected by the end of summer and complete the project in the fall of 2018. The project is expected to take up to 4 weeks.
